Whereas, vide Order at reference No. 1 above issued by the Registrar of Co-operative Societies u/s. 86 (1) of the Goa Co-operative Societies Act, 2001 read with Rule 116 (1) of the Goa Co-operative Societies Rules, 2003, Adv. Manguirish Kenkre, FO-3, 1st floor, Gurukrupa Building, Opp. Sai Color Lab, F. L. Gomes Road, Vasco-da-Gama, Goa was appointed as the Registrar's Nominee for deciding the disputes arising in any of the Co-operative Societies referred to him by the Registrar of Co-operative Societies/Asst. Registrars of Co-operative Societies.

And whereas, vide Order at ref. No. 3 above, the Registrar of Co-op. Societies, in exercise of powers conferred u/s. 123 (B) of the Goa Co-operative

Societies Act, 2001 read with Circular at ref. No. 2 above had appointed Adv. Manguirish Kenkre as the dedicated Registrar's Nominee authorizing him to entertain and decide all the disputes referred to him by The Sahakar Urban Co-operative Credit Society Ltd., Vasco-da-Gama [Reg. No. 8-Res-(a)-57//South Goa/1992 dt. 3-4-1992] without referring to this office and the initial period of authorization was for 1 year from 21-12-2020 to 20-12-2021.

And whereas, upon the request of the Society vide letter referred at Sr. No. 4 above, the said appointment was extended for a further period of one year i.e. from 21-12-2021 to 20-12-2022, vide Order referred at Sr. No. 5 above.

And whereas, the Sahakar Urban Co-operative Credit Society Ltd., Vasco-da-Gama vide letter at ref. No. 6 above has requested for extension of the said authorization for a further period of one more year from 21-12-2022 to 20-12-2023.

Now therefore, in exercise of powers conferred under Section 123B of the Goa Co-operative Societies Act, 2001, I, the Registrar of Co-operative Societies hereby extend the authorization of Adv. Whereas, vide Order read at Sr. No. 1 above, Adv. Shivaji B. Sinai Bhangui, r/o G/1, A-4, Caculo Enclave, behind Caculo Mall, St. Inez, Panaji, Goa was appointed as Registrar's Nominee under Section 86(1) of the Goa Co-operative Societies Act, 2001 (Goa Act No. 36 of 2001) (hereafter referred as "Act") read with Rule 116(1) of the Goa Co-operative Societies Rules, 2003 and his name is reflecting at Sr. No. 24 of the said Order.

And whereas, vide this office Order read at Sr. No. 3 above, Adv. Shivaji B. Sinai Bhangui was authorized as Independent Nominee of the Registrar of Co-operative Societies for the Bicholim Urban Co-operative Bank Ltd., "Nandavan", Central Office, Bicholim, Goa (hereafter referred as "said Bank") to entertain all the disputes referred to him in matters of recovery of outstanding loans of the said Bank, without routing through this Department.

And whereas, the said authorization was initially for a period of one year w.e.f. 01-04-2022 to 31-03-2023. And whereas, vide letter dated 12-06-2023 read at Sr. No. 4 above, the said Bank has requested this office to extend the said authorization for further period of one year.

And whereas, it was observed that there was an inordinate delay in submitting the proposal to this office for extending the term of Adv. Shivaji B. Sinai Bhangui as the Independent R's Nominee of the said Bank and therefore this office vide letter dated 09-08-2023 referred at Sr. No. 5 above, requested the said Bank to submit its clarification for not submitting the proposal for such extension within stipulated time.

And whereas, the Bank vide letter dated 11-08-2023 referred at Sr. No. 6 above, clarified that the delay was not intentional and hence requested to condone the delay and grant extension for further period w.e.f. 01-04-2023.

Now therefore, in exercise of the powers conferred under Section 123(B) of the Goa Co-operative Societies Act, 2001 read with Rule 116 of the Goa Co-operative Societies Rules, 2003, I, the undersigned Registrar of Co-operative Societies do hereby extend the term of Adv. Shivaji B. Sinai Bhangui, r/o G/1, A-4, Caculo Enclave, behind Caculo Mall, St. Inez, Panaji, Goa as Independent R's

Nominee for a period of one year with retrospective effect from 01-04-2023 to 31-03-2024 for the Bicholim Urban Co-operative Bank Ltd., "Nandavan", Central Office, Bicholim, Goa.

Further, when a purported dispute is referred by the said Bank, the above named Independent R's Nominee is authorized to first decide under subsection (1) of Section 86 of the Goa Co-operative Societies Act, 2001 whether the matter referred by the said Bank involves a dispute and pass appropriate Orders under sub-section (1) of Section 86 of the said Act.

Further, only upon the Independent R's Nominee satisfying that there exists a dispute, he shall proceed to adjudicate the same and give Award accordingly. The Independent R's Nominee shall abide by the terms and conditions on which he was originally appointed as Registrar's Nominee vide Order read at Sr. No. 1 above.

This extension of authorization as Independent R's Nominee is liable to be withdrawn at any time without assigning any reason at the discretion of the undersigned.

# Order

No. 3/1995/GASS/Indus/CORRES/3179

- Read: 1. Show Cause Notice under Section 20 (1) of the Goa Co-operative Societies Act, 2001 and Rules, 2003.
  - Reply dated 08-09-2023 submitted by Shri Sanket Naik Mule, Chairman, the Gramodhyog Audhogik Sahakari Saunstha Ltd.

(Under Section 20 read with Section 92 of the Goa Co-operative Societies Act, 2001)

This order shall dispose off the show cause notice No. 3/995/GASS/Indus/CORRES/2921 dated 31-08-2023 wherein, as to why an Order should not be passed under Section 20(1) of the Goa Co-operative Societies Act, 2001 declaring that said Society is de-registered and also for making other incidental and consequential orders under sub-section (2) of the Goa Co-operative Societies Act, 2001.

The brief facts of the case are as under:

The Gramodhyog Audhogik Sahakari Saunstha Ltd., C/o. Shri R. G. Mule, Chairman, Goa State Co-operative Bank Ltd., Panaji-Goa was registered in the year 1995 in terms of Rule 9(7)(a) of the Maharashtra Co-operative Societies Rule, 1962 and classified as "Producer Society under sub-classification Industrial Producer Society" under code symbol No. RCS/Industrial-1/Goa as was in force in the State of Goa and now, deemed to be registered under the Goa Co-operative Societies Act, 2001 and Rules, 2003 in the office of the Registrar of Co-operative Societies, Panaji and same was transferred to office of the Assistant Registrar of Co-operative Societies, Central Zone, Panaji vide order No. 54/4/Gen/TS/RCS/1562 dated 03-09-2009.

And whereas, as per Section 72 of the Goa Co-operative Societies Act, 2001 (hereinafter referred to as "the said Act"), every society shall in each co-operative year, hold its Annual General Meeting within 6 months from the close of the co-operative year and place before the General Body, an audited statement of accounts for the year. General Body Meeting is the only forum whereby all the members have right to express their views, grievance, suggestions, new ideas & pragmatism for the upliftment and well-being of the members at large and society in particular. Likewise, timely audit of the funds of the society brings transparency in the affairs of the society as much as it builds trust in the minds of the members towards the management, its functioning and creates a healthy environment.

And whereas, in the instant case it is revealed from the records available at the level of this office that, the society has failed to convene Annual General Body Meetings of its members in accordance with Section 72 of the Act since 2009 and thus has failed to place before the General Body an audited statement of accounts of the society. Further, the society has failed to get its accounts audited since financial year 2008-2009 onwards, thereby defeating the purpose of Section 74 of the Act, wherein, it is mandated that accounts of the society shall be audited every year by an auditor from panel of auditor appointed by the General Body of the society.

Whereas, in terms of Section 81 of the Goa Co-operative Societies Act, 2001 every society has to file returns within six months of the close of every co-operative year, to the Registrar and thus avoid levy of further penalties as applicable under Rule 113 of the Goa Co-operative Societies, 2003. However, it is transpired from the office records

that the society has failed to file returns under Section 81 of the Goa Co-operative Societies Act, 2001 thereby causing revenue loss to the Government.

And whereas, elections to the Board of Directors of the society are required to be held as per the provision of sub-section 5 of Section 66 of the said Act. The election of the Board of Directors shall be conducted before expiry of the term of the Board of Directors so as to ensure that the newly elected members of the board assume office immediately on the expiry of the office of members of the outgoing board. The election to the Board of Directors and office bearers of all the societies shall be conducted by the Registrar or by such authority or body as may be authorized by the Government by notification in Official Gazette and in such manner as may be prescribed. However, Board of Directors of the society failed to approach this office for conduct of election of Board of Directors of the society and continued to hold the office illegally.

And therefore, it shall be endeavor of the board to scrupulously comply with the statutory requirements in relation to holding of Annual General Meeting, conducting audit, filing of returns, holding of elections etc.

And whereas, by contravening the provisions of the Act in relation to get its accounts audited and place before the members in the Annual General Body Meeting the board has not only made itself liable for disqualification as provided under Section 61 of the Goa Co-operative Societies Act, 2001, but has also deprived the members of their legitimate right to know about the financial standing/status of the society.

So also, by not placing the audited statement of accounts before the General Body, it has given wide scope to believe that there can be possibility of financial embezzlement and concealment of material facts. Being the custodian of the funds of the members of the society it was imperative for the board to get the timely audit done and place before the General Body the audited statement of accounts.

And whereas, in terms of Section 61 of the said Act, all the directors of the board shall incur disqualification for a period of six years for being chosen as directors and shall be ineligible to continue as director of the society, if during their term as directors of the society, they failed to conduct the Annual General Body Meeting within the stipulated time and place before the General Body

an audited statements of accounts and they did not file the return within stipulated time as provided in Section 81 of Goa Co-operative Societies Act, 2001.

Therefore, in terms of Section 61 of the said Act, the entire board incurs disqualification for not complying with the statutory requirements of holding the Annual General Body Meeting and placing audited statements of accounts before the General Body of the society within the stipulated time limit.

And whereas, on going through the available records rested with this office pertaining to your society, it is observed that the audit of the society is pending since 2009 and therefore this office is unable to ascertain the factual position regarding working and the financial standing of the society as on date. Further, it is also observed from the available records that society is not regular in submitting proceeding of the General Body Meetings conducted by the society. As such this office is not able to ascertain as to whether your society is holding the Annual General Body Meetings in terms of Section 72 of the Goa Co-operative Societies Act, 2001 or otherwise. Besides, no records are available regarding filing of returns in terms of Section 81 of the Act and the fees prescribed thereto.

And whereas, vide Notification No. 60/137//Amendment/2020/TS-I/RCS/4579 dated 28-02-2023 the amended provision of the Goa Co-operative Societies Act, 2021 (Goa Act No. 34 of 2021) have been made effective from 01-04-2023 (hereafter referred to as 'Act') in order to ensure proper implementation of Co-operative provisions, proper management of the business of all the Co-operative Societies functioning in the State of Goa.

And whereas, in terms of provision of sub-section 4 of Section 73 of the Goa Co-operative Societies Act, 2001, it is mandatory upon every society to prepare its financial statements of accounts as mentioned therein under said Section within 45 days of the close of the financial year and submit copies of the said statement of accounts to the Registrar and the statutory auditor within 15 days from preparation of such accounts.

And whereas, the above mentioned statutory time limit for preparation and submission of such statements of accounts have ended on 15th May, and 30th May respectively. However the society has not complied with the above mentioned section of the Act.

In view of the above, this office vide letter No. 3/1995/GASS/INDUS/CORRES/126 dated 13-04-2023 had sought clarification from the society. So also, this

office had issued show cause notice No. ARCS/2022-23/SCN/Unit-III/2198(a) dated 20-07-2023 under Section 73(5) of Goa Co-operative Societies Act, 2001, for not submitting unaudited statement of accounts. Both the above correspondance were sent on the registered address of the society, however same were undelivered and returned back to this office by the postal authority.

And whereas, vide this office memorandum No. 3-1995/GASS/INDUS/CORRES/2843 dated 29-08-2023 constituted a team of officials to visit the registered office of the society and find out whereabouts of the Gramodhyog Audhyogik Sahakari Saunstha Ltd., and directed to submit detail report in the matter to this office. Inspecting officers had submitted their reports and informed that the building Sahakar Sankul consist of 8 floors i.e. 1) the ground floor consist of Head Office Branch of the Goa State Co-operative Bank Ltd., Panaji, 2) 1st floor consist of Board of Directors, Office of the Goa State Co-operative Bank Ltd., 3) 2nd floor consist of Accounts Section and Planning & Statistics Section of the Goa State Co--operative Bank Ltd., 4) the 3rd floor consist of Administration Section, Loans & Advances Section, Legal Section, Recovery Section and Inspection & Audit Section of the Goa State Co-operative Bank Ltd., 5) 4th & 5th floor is leased out to the office of the Registrar of Co-operative Societies, Government of Goa, Panaji, 6) 6th floor consist of conference hall of the Goa State Co-operative Bank Ltd. and 7) 7th floor consis of MIS Section (computer Server Room) of the Goa State Co-operative Bank Ltd., However, there is no such society/society premises/societies office in the name of The Gramodhyog Audhyogik Sahakari Saunstha Ltd., at Goa State Co-operative Bank Ltd. is found to be functioning in the premises of the Goa State Co-operative Bank Ltd., Sahakar Sankul, Patto, Panaji-Goa.

Further, the Inspecting Officers had discussed with Shri Anant M. Chodankar, Managing Director of the Goa State Co-operative Bank Ltd., on 30-08-2023, he informed that there is no such society in the name of the Gramodhyog Audhyogik Sahakari Saunstha Ltd. in the premises of the Goa State Co-operative Bank Ltd. nor they had issued any NOC/Consent letter to any such type of society to use The Goa State Co-operative Bank Ltd. address for any correspondence.

And whereas, since the registered address of the society shown as The Goa State Co-operative Bank Ltd., Panaji this office vide letter No. 3/1995//GASS/INDUS/CORRES/2847 dated 29-08-2023 has requested the Managing Director of The Goa State Co-operative Bank Ltd., Panaji to inform in writing whether Bank had granted any lease of any part of

Bank premises to set up the said society i.e. Gramodhyog Audhyogik Sahakari Saunstha Ltd., and if yes kindly provide certified copy of lease agreement to this office records. In this regards Shri Anant Chodankar, Managing Director of The Goa State Co-operative Bank Ltd., Sahakar Sankul, Panaji, Goa, informed this office vide letter No. GSCB/ADM/2023-2024/3736 dated 30-08-2023, that the Bank has not granted any lease of any part of bank premises to set up the Gramodhyog Audhyogik Sahakari Saunstha Ltd.

After conducting the detail inquiry prima facie, it is proved that the said society was never existing and operating from the address "C/o. Shri R. G. Mule, Chairman, Goa State Co-operative Bank Ltd., Panaji-Goa" but the chief promoter had misrepresented the facts and obtained the registration by submitting fake non-existing address and therefore the society is liable to be deregistered on the grounds of misrepresentation.

And whereas, for the above reasons, it is clear that the applicant/chief promoter had obtained registration of the above mentioned society based on misrepresentation by showing fake registered address, so also the purpose for which society is registered are not found to be served and hence is liable to be registered under sub-section (1) of the Section 20 of the Goa Co-operative Societies Act, 2001.

Considering the aforesaid lapses on the apart of the society show cause notice dated 31-08-2023 was issued under Section 20(1) of the Goa Co-operative Societies Act, 2001 and Rules 2003 for deregistration of the society to the Chief Promoter, Boards of Directors and all the members of the society to appear before undersigned on 08-09-2023 at 11.00 a.m. for personal hearing in the matter the copy of said show cause notice was placed on the notice board of the registered address of the aforesaid society, O/o. Registrar of Co-operative Societies, Government of Goa, Panaji, Goa, O/o. the Goa State Co-operative Bank Ltd., Panaji, O/o. the Goa State Co-operative Union Ltd., Panaji, and O/o. Asstt. Registrar of Co-operative Societies, Central Zone, Panaji. So also, taking into consideration provision of Rule 16(1) of the Goa State Co-operative Rules, 2003, the notice of the personal hearing to be held on 08-09-2023 at 11.00 a.m. in respect of the show cause notice issued under Section 20 of sub-section 1 of the Goa Co-operative Societies Act, 2001 for deregistration of the society was published in local news paper i.e. "Goan Varta" on 01-09-2023.

The copies of showcause notice were served via Registered Post with Acknowledge Due (R.P.A.D.) to 1) the Chairman, Gramodhyog Audhogik Sahakari Saunstha Ltd., C/o. Shri R. G. Mule, Chairman, Goa State Co-operative Bank Ltd., Panaji, Goa, 2) the Chief Promoter, Shri R. G. N. Mule, Bhagwati Niwas, Dhavali, Ponda, Goa, 3) The Board of Directors, Gramodhyog Audhyogik Sahakari Saunstha Ltd., C/o. Shri R. G. Mule, Chairman, Goa State Co-operative Bank Ltd., Panaji-Goa.

It is deemed service U/S 27 of the General Clauses Act, when any notice is dispatched by registered post by paying full postage and the postal envelop is returned undelivered by postal authorities, then it is deemed to have been served upon the addressee on the date on which in the normal course of post it would have been delivered.

On the date of hearing i.e. 08-09-2023 at 11.00 a.m. Shri Sanket Naik Mule, purported to be Chairman of Gramodhyog Audhyogik Sahakari Saunstha Ltd., remained present and submitted his written reply to the show cause notice issued. However, the purported Chairman Shri Sanket Naik Mule had not produced any documentary evidence before this authority, that he is the elected/appointed Director//Chairman of the said society. Also there was no such records available with this office regarding elected//appointment of Chairman. Apart from Shri Sanket Naik Mule no other Board of Directors, Members nor the Chief Promoter remained present for the aforesaid hearing.

And whereas, I have gone through the reply submitted by Shri Sanket Naik Mule purported to be Chairman of Gramodhyog Audhyogik Sahakari Saunstha Ltd., wherein he has denied all the contents of the show cause notice and informed this authority on the date of hearing i.e. on 08-09-2023 at 11.00 a.m. that the all the financial audits are completed upto 31-03-2023 and requested time to submit the audit reports upto 31-03-2023 & Proceedings of the Annual General Meeting held upto 2022-23. Accordingly, this authority fixed the next hearing on same day i.e. 8-09-2023 at 04.00 p.m. to submit the audited statements of accounts along with audit report audited up to 31-03-2023 and proceedings of the Annual General Meeting held up to 2022-23.

During the hearing i.e. on 08-09-2023 at 04.00 p.m. the purported Chairman Shri Sanket Naik Mule, failed to remain present and to submit the aforesaid information along with documentary evidence to this authority.

Considering the above position, and after verifying all office records in this office, I am of the considered opinion that the Annual General Body Meeting of the aforesaid society were not held as per the provision of Section 72 of the Goa Co-operative Societies Act, 2001, that accounts of the society

remained unaudited from 2008-09 onwards, that filling of returns as required under Section 81 of the said Act has also not been filed, election of the society had not conducted as required in terms of Section 66 of the said Act. The Board of Directors nor any members of the society had never turned around this office any time since 2009 for complying above mention requirements.

Thus, it is established that this society was never in actual existence since its inception till date, but was only existing on paper. The Board of Directors of the society had miserably failed to comply the above statutory provisions of the Act, nor are any members interested to participate in the affairs of the society.

It is established that the applicant Chief Promoter had obtained registration of the above mentioned society based on misrepresentation by showing fake registered address, and the society never functioned from that address or from any other place in the State of Goa.

It is revealed from the declared Bank Account of this Society that there were no financial transactions on said bank account with Taleigao Branch of the Goa State Co-operative Society, except very few transactions of crediting interest and to prevent the bank account from being classified as dormant. The Society neither has any place of business, nor any asset in the State of Goa.

So also, the purpose for which society is registered are not found to be served and hence the Society is liable to be de-registered under sub-section (1) of Section 20 of the Goa Co-operative Societies Act, 2001.

In view of the above, I pass the following.

# **ORDER**



#### **AWARD**

# (Delivered on this the 24th day of the month of August of the year 2023)

By Order dated 09-07-2013, bearing No. 28/33//2013-Lab/475, the Government of Goa in exercise of powers conferred by Section 10(1)(d) of the Industrial Disputes Act, 1947, has referred the following dispute for adjudication to this Tribunal:-

- "(1) Whether the action of the Management of M/s
  Ananya Manpower Solutions Private Limited,
  Panaji, a contractor to M/s G. K. B. Ophthalmics
  Limited, Thivim Industrial Estate, Karaswada,
  Mapusa, Goa, in terminating the services of it's
  following nine workmen, with effect from
  28-03-2013, is legal and justified?
  - (1) Shri Bhausaheb V. Desai.
  - (2) Shri Kunal D. Parab.
  - (3) Shri Anand K. Chari.
  - (4) Shri Shrikrishna Popkar.
  - (5) Shri Satyavan Mahale.
  - (6) Shri Sushant S. Narvekar.
  - (7) Shri Sanjay B. Mopkar.
  - (8) Shri Pravin P. Khanolkar.
  - (9) Shri Ram S. Kerkar.
- (2) If not, what relief the workmen are entitled to?"
- 2. It came to be registered in this Tribunal as Reference No. IT/13/2013.
- 3. The Workmen/Party I has filed their Statement of Claim. Party II(1) has filed its Written Statement. Party I has filed their Rejoinder. During the course of proceedings, Party II(2) was impleaded. Party II(2) has filed its Written Statement. Party I has filed their Rejoinder to the Written Statement of Party II(2).
- 4. The case of Party I is that the workmen were employed by Party II(1) in the Factory of the Principal Employer, namely, G.K.B. Ophthalmics Ltd. at Karaswada, Mapusa-Goa/Party II(2). That the Workmen (Party I) were in continuous employment in the said Factory. That by Resolution dated 24-03-2013, all the workmen named in the present Order of Reference unionized themselves under the banner of the "Goa Trade & Commercial Workers' Union". That the 9 workmen who were actively involved in forming the Union were arbitrarily refused employment w.e.f. 28-03-2013. That this was done by Party II(1) in collusion and in consultation with Party II(2). That this was done in order to spread

fear among the other unionized workmen. That the action of Party II(1) amounts to unfair labour practice. That all the workmen (Party I) are unemployed. Therefore, it is prayed that the action of Party II(1) in refusing employment/termination of service of all the workmen named in the present Order of Reference be held to be illegal, unjust and bad in law. That all the workmen named in the Order of reference be reinstated back in service with full back wages, continuity in service and all other consequential benefits.

- 5. The case of the Party II(1) is that Party II(1) and M/s G.K.B. Ophthalmics Limited/Party II(2) had entered in various Staffing Services Agreements. That the last of such agreements were for a period of 11 months from 02-01-2012 to 01-01-2013. That this agreement was orally extended upto 31-03-2013. That under these agreements, Party II(1) was deploying trained workers to work in the Factory of M/s G.K.B. Opthalmics Limited/Party II(2). That upon the termination of the agreement between M/s. G.K.B. Opthalmics Limited/Party II(2) and Party II(1), the workmen were instructed to report to the Office of Party II(1) from 01-04-2013 to settle their accounts. That the workers at Sr. No. 5 and 9 in the Order of Reference absented from work w.e.f. 26-03-2013. That the other workmen named in the Order of Reference absented themselves from work w.e.f. 28-03-2013. That the Workmen (Party I) also did not report to the Office of Party II(1) on 01-04-2013 as notified. That the Workmen (Party I) were engaged for a specific period of a contract which has been terminated. That Party II(1)has no option but to terminate the workmen w.e.f. 01-04-2013. That thereafter some of the workers listed in the Order of Reference approached Party II(1) stating that they have secured alternate employment and they are not interested in working for Party II(1). That these workers have also withdrawn their Provident Fund. It is denied that all the workmen named in the present Order of Reference are unionized.
- 6. It is denied that the Workmen (Party I) have been refused employment because they unionized themselves. It is denied that it amounts to unfair labour practice. It is denied that all the workmen (Party I) are unemployed. That the Goa Trade and Commercial Workers' Union has no locus standi to raise a dispute regarding the 9 workmen named in the Order of Reference. That Party I are not entitled to any relief.
- 7. Party I has stated in their Rejoinder to the Written Statement of Party II(1) that none of the workmen have obtained alternate employment and none of them have withdrawn their Provident Fund.

It is denied that the workmen were employed for a specific period of a contract which has been terminated. It is denied that all the workmen were instructed to report to the Office of Party II(1) from 01-04-2013 to settle their accounts as the work for which the workmen were recruited had come to an end. It is denied that the workmen at serial No. 5 and 9 in the Order of Reference absented from work w.e.f. 26-03-2013 and the other workmen absented from work w.e.f. 28-03-2013. It is denied that the Goa Trade & Commercial Workers' Union has no locus standi to raise a dispute on behalf of the 9 workmen named in the Order of Reference. Therefore, it is prayed that the reliefs sought in the Claim Statement be granted.

- 8. Party II(2) has filed its Written Statement. Party II(2) states that it has its Factory at Tivim Industrial Estate, Mapusa-Goa. That Party II(2) has permanent employees doing skilled and unskilled jobs. That Party II(2) also engages contractors for doing certain specific jobs. That one such contractor was Party II(1). That Party II(2) and Party II(1) entered into a contract. That the contract was for a period of 11 months from 02-01-2012 to 01-01-2013 which was orally extended upto 31-03-2013.
- 9. That the performance of Party II(1) was unsatisfactory. That Party II(2) issued letter dated 01-04-2013 and terminated the contract with Party II(1) with effect from 31-03-2013. That Party II(1) was performing the contract by engaging its own workers. That Party II(2) was not concerned with the workmen of Party II(1). That on the termination of the contract, Party II(1) withdrew its workmen from the Factory premises. It is denied that Party I was in continuous employment of Party II(1) and Party II(2). It is denied that Party I were terminated from service because they were organizing themselves under a trade union. It is stated by Party II(2) (in Para 3 of the Written Statement) that the Order impleading Party II(2) is due to misappreciation of fact and law and the said Order and consequent summons are liable to be recalled. In paras 4(a) to (h) of the Written Statement, Party II(2) states that Party II(2) is neither a necessary nor a proper Party. That there is no employer-employee relationship between Party II(2) and Party I. That the relationship between Party II(2) and Party II(1) was that of a Contractor and Principal Employer. That the contract has been terminated with effect from 31-03-2013. That all the workmen have settled the matter with Party II(1) and have also withdrawn their Provident Fund. That Goa Trade and Commercial Workers' Union has no locus standi to espouse the claims of the Party I (Workmen). Therefore, it is prayed that it be held that impleading Party II(2) to these proceedings is bad-in-law and is not necessary to decide this reference.

10. In their Rejoinder to the Written Statement of Party II(2), Party I denies that impleadment of Party II(2) is due to misappreciation of facts and law and is liable to be recalled. It is denied that Party II(2) is neither a necessary nor a proper Party. It is denied that there is no employer-employee relationship between Party II(2) and Party I. It is denied that the contract between Party II(2) and Party II(1) has been terminated with effect from 31-03-2013. It is denied that all the workmen have settled the matter with Party II(1) and have also withdrawn their Provident Fund. It is denied that the Goa Trade and Commercial Workers' Union have no locus standi to espouse the claim of Party I. It is denied that Party I are not entitled to any relief.

11. The following issues and additional issues were framed by this Tribunal:-

#### **ISSUES**

- Whether the Party I/workmen prove that they were in continuous employment of Party II(1) in the Factory of the Principal Employer GKB Ophthalmics Ltd. at Karaswada, Mapusa, Goa?
- 2. Whether the Party I proves that they have been refused employment by Party II(1) in collusion and in consultation with the Principal Employer M/s GKB Ophthalmics Ltd. with malice and malafide intention in order to take revenge on them for unionizing themselves under the Registered Trade Union w.e.f. 28-04-2013?
- 3. Whether the Party II(1) proves that Goa Trade and Commercial Workers' Union has no locus standi to raise this dispute?
- 4. Whether the Party II(1) proves that no dispute was raised against them by Party I or any of the workmen mentioned in the order of reference?
- 5. What relief? What Award?

# ADDITIONAL ISSUES

- 4A. Whether the Party II(2) proves that impleading the Party II(2) is due to misappreciation of facts and/or law as contended in para 3 of the Written Statement of Party II(2)?
- 4B. Whether the Party II(2) proves that the reference is not maintainable as against the Party II(2) and the order impleading the Party II(2) is liable to be recalled/withdrawn on the grounds (a) to (h) of said para 4?

12. During the course of proceedings, Party I and Party II(1) have filed the following Terms of Settlement (Exhibit 50 Colly):-

#### Terms of Settlement

- I. The Parties agree that since the contract of Contractor was terminated w.e.f. 01-04-2013 and that the workmen were not willing to accept the job elsewhere, the workmen do not press for reinstatement with the Party II(1) and/or Party II(2).
- II. It is further agreed between the Parties that all the workmen who are parties to the references No. IT/13/2013; IT/17/2013 and IT/18/2013 shall be paid a consolidated amount of Rs. 15,000/- per worker in full and final settlement of all their claims.
- III. The workmen agree to permit deduction of Rs. 450/- each from the gross amount payable to each workperson and pay the said deducted amount towards Union fund on or before 31-08-2023 and the Cheque will be drawn in favour of "Goa Trade & Commercial Workers' Union", Panaji, Goa, by the Contractor Ananaya Manpower Solutions Pvt. Ltd.
- IV. It is agreed between the Parties that the amount payable by the Contractor to the workmen in the manner hereinabove provided for are in full and final settlement and satisfaction of all the claims of the workmen against the Contractor including claims for compensation for loss of office or otherwise whatsoever.
- V. The Parties agree that these consent terms shall be filed in pending Reference No. IT/13//2013; IT/17/2013 and IT/18/2013 for Award in terms of this settlement.
- VI. The Management of Contractor shall pay the amount agreed, after deducting the Union fund, to the workmen directly as and when they approach the Contractor against a valid receipt.
- 13. Party I and Party II(1) have filed an application stating that an Award be passed in terms of the settlement.
- 14. I have gone through the records of the case and the Memorandum of Settlement at Exhibit 50 Colly and I am convinced that the Memorandum of Settlement are just and fair and are in the interest of the Workmen/Party I and the Employer/Party II(1) and therefore the same are accepted.

Hence I pass the following:-

# ORDER

- (i) The reference in IT/13/2013 stands awarded as per the Terms of Settlement filed by them at Exhibit 50 Colly.
- (ii) The Terms of Settlement are as follows:-

#### Terms of Settlement

- I. The Parties agree that since the contract of Contractor was terminated w.e.f. 01-04-2013 and that the workmen were not willing to accept the job elsewhere, the workmen do not press for reinstatement with the Party II(1) and/or Party II(2).
- II. It is further agreed between the Parties that all the workmen who are parties to the references No. IT/13/2013; IT/17/2013 and IT/18/2013 shall be paid a consolidated amount of Rs. 15,000/- per worker in full and final settlement of all their claims.
- III. The workmen agree to permit deduction of Rs. 450/- each from the gross amount payable to each workperson and pay the said deducted amount towards Union fund on or before 31-08-2023 and the Cheque will be drawn in favour of "Goa Trade & Commercial Workers' Union", Panaji, Goa, by the Contractor Ananaya Manpower Solutions Pvt. Ltd.
- IV. It is agreed between the Parties that the amount payable by the Contractor to the workmen in the manner hereinabove provided for are in full and final settlement and satisfaction of all the claims of the workmen against the Contractor including claims for compensation for loss of office or otherwise whatsoever.
- V. The Parties agree that these consent terms shall be filed in pending Reference No. IT/13/ /2013; IT/17/2013 and IT/18/2013 for Award in terms of this settlement.
- VI. The Management of Contractor shall pay the amount agreed, after deducting the Union fund, to the workmen directly as and when they approach the Contractor against a valid receipt.
- (iii) No orders as to costs.
- (iv) Inform Government accordingly.


